

Booking Terms and Conditions

By completing and returning the Booking Form to ASI you, the sponsor/exhibitor will, upon notification of acceptance of your booking application by ASI, be entering into a legally binding contract with us for participation in ASI 2025 upon the terms of the Booking Form and the terms and conditions set out following:

Acceptance and payment

- ASI may accept or decline any application for booking at its discretion. Upon ASI notifying the sponsor and/or exhibitor of acceptance of a booking, a legally binding contract shall come into existence between ASI and the sponsor and/or exhibitor for participation in the Meeting upon the terms of the Booking Form and these terms and conditions. If, however, ASI declines the application, it will refund to the intending exhibitor, partner or sponsor any monies then paid.
- All sponsorship and exhibition packages are GST exclusive and are in Australian Dollars. A 50% deposit payment is due at the time of booking to confirm the sponsorship. Booths will be allocated strictly in the order that completed booking forms and deposit payment is received (which the exhibitor agrees to accept) and shall be confirmed by us in writing when accepting the booking and acknowledging receipt of payment. The remaining 50% is due by 24 May 2025.
- In the event of cancellation by the sponsor and/or exhibitor on or after 24 May 2025, no refund of any monies paid will be made. Cancellations made prior to 24 May 2025 will incur an administration fee equivalent to 10% of the total booking. Any cancellation must be advised in writing to annualmeeting@immunology.org.au.

Insurance

Neither ASI nor the venue owner/manager and their respective employees or agents accept any liability for damage to or loss of any equipment, materials or other belongings brought in by or on behalf of a partner, sponsor and/or exhibitor to the venue of the Meeting. The sponsor and/or exhibitor is advised to take out appropriate insurance cover accordingly.

Unavoidable occurrences

In the event that the opening, closing or duration of the Meeting is cancelled or amended whether by decision of ASI, the venue owner or manager or any sponsor, and for any reason including but not limited to, fire, flood, labour disputes, natural disasters, civil disorders, riots, insurrections, work stoppages, slowdowns or disputes, pandemic or other similar events, then the sponsor shall not be entitled to any refund or to claim for any compensation, loss or damage.

Booths

- The exhibitor shall not assign, sublet, or share the whole or any part of the exhibitor's allocated booth space without the prior written consent of ASI.
- ASI reserves the right to redesign the location, dimensions or floor plan of the exhibitor's booth or any other booth or associated or adjoining area and the exhibitor will accept such re-allocation or re-design without any claim for a reduction in the amount payable or otherwise.
- The exhibitor must not erect any sign, display or obstruction which extrudes beyond the exhibitor's allocated booth whether into an adjoining exhibitor's space.
- The exhibitor must not damage in any way the walls, floors, ceilings or any other surface of the exhibition area and must reimburse ASI for the cost of reinstating any damage caused by the exhibitor.

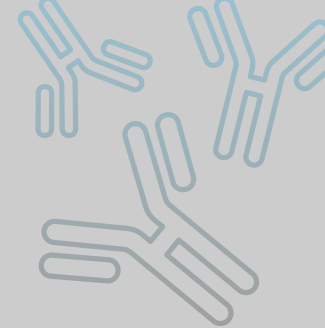

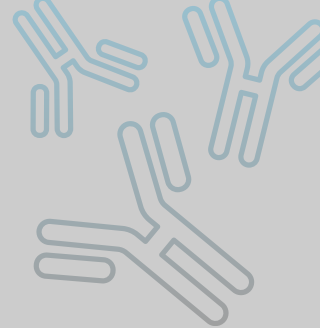
